Why this seminar?

In development policy of the Netherlands the active engagement of the private sector is increasingly seen as a core condition to achieve sustainable development and poverty alleviation. This seminar analyses the experiences, dilemma's and perspectives of the Dutch private sector in shaping their international Corporate Social Responsibility policies, with a particular focus on their impact on tropical forests and their role in the international cooperation of the Netherlands. This seminar aims to take stock of the state of affairs, recent insights and developments, share experiences and identify key steps in the way forward in policy and business development.

Questions that will be addressed include:

- 1. How do companies comply with CSR criteria and effectively take up the roles attributed to them in the Dutch development policy?
- 2. What specific measures have companies taken to mitigate their footprint on tropical forests and/or to promote sustainable forest management?
- 3. What can realistically be expected from companies and what should governments and NGOs take up?
- 4. What are the main dilemmas, needs and opportunities for putting CSR to practice, and how are these addressed by different actors?

Background

In development policy of the Netherlands the active engagement of the private sector is increasingly seen as a core condition to achieve sustainable development and poverty alleviation. International cooperation should catalyse inclusive growth that is basically sustained by the domestic private sector. Development money should basically be invested in the strengthening of knowledge, capacities and enabling conditions of domestic enterprise. Public money should be used to a larger extent to leverage private investment and private and public-private partnerships. In the implementation of its development policy the Netherlands government sees a leading role for the Dutch private sector. Business linkages between the Netherlands and developing countries are manifold and diverse and its local presence, organisation and expertise is a strong advantage. In the view of the Netherlands government the Dutch private sector has a lot to offer, but also has to take active social and environmental responsibility abroad throughout their production and value chains, hence contributing to a "Green and Equitable Global and Local Economy".

Companies are increasingly aware of the need and opportunities to materialize Corporate Social Responsibility (CSR) policies and strategies in their daily business. Societal demands and environmental concerns, reputation, risk mitigation and long term resource access and security are among the factors that drive this development. Internationally the Netherlands private sector is profiled as a frontrunner in CSR. In the Netherlands many companies and sectors directly or directly influence the state of tropical forests, their management and conservation: through forest concessions, agricultural and timber production and trade chains, financing and investment and otherwise.

This seminar analyses the status, experiences and perspectives of the Dutch private sector in shaping their international CSR policies, with a particular focus on their impact on tropical forests. How have companies equipped themselves to comply with CSR criteria in general (f.e. the OECD guidelines on CSR) and to effectively take up the roles attributed to them in the Dutch development policy? What specific measures have companies taken to mitigate their footprint on tropical forests and/or to promote sustainable forest management. What can realistically be expected from companies and what should governments and NGOs take up? What are the main problems, needs and opportunities for putting CSR to practice and how are these addressed by different actors? By bringing together and sharing the experiences of diverse networks of experts the seminar aims to identify practical steps and policies for CSR strategies for tropical forests. The seminar takes the outcomes of Rio+20 on board, and is well-timed to provide inputs to the new Dutch government.
